Children have many rights, like the right to life, safety, family, identity, expression and protection from violence among many others.


Moreover, all children the world over have the same rights including those who are homeless, fleeing conflict, poor, hungry, sick, out of school or abandoned.

These rights are set out in The Convention on the Rights of the Child, which is an international legal commitment by world leaders to protect every child and to fulfill their rights.






NO DISCRIMINATION






DRAW A LINE BETWEEN MATCHING PAIRS





CHILDREN'S VIEWS


Children have the right to give their opinions freely on issues that affect them. Adults should listen and take children seriously.


FOOD, CLOTHING,

BEST INTERESTS
